## ASSISTANT BARBER INSTRUCTOR REQUIREMENTS TO BECOME ELIGIBLE FOR EXAMINATION

Number of instructors/assistant instructors employed pursuant to 71-208.02:

- (3)
- **one** registered barber instructor or assistant barber instructor shall be employed for each **fifteen** students or fraction thereof
  - each school shall have not less than **two** instructors, one of whom shall be a registered barber instructor, regardless of the number of students
  - additional assistant barber instructors are permitted on a working ratio of **two** assistants for each registered barber instructor

(5)(a) A person shall be eligible for registration as an assistant barber instructor if he or she:

- has been a licensed and actively practicing barber for **one** year
- is currently enrolled, or will enroll at the first college enrollment date, in an educational program leading to completion of the required college hours
- has paid the required fee

(5)(b) A person registered pursuant to subdivision (a) of this subsection, may serve as an assistant barber instructor under indirect supervision if he or she:

i. has completed **9** college credit hours, **3** hours each in:

- methods of teaching
- curriculum development
- special vocational needs

ii. has completed **nine months** of training under direct in-house supervision of an active, full time registered barber instructor or in lieu thereof has completed the requirements of a barber instructor course developed or approved by the Board

(5)(c) A report of college credits earned shall be submitted to the Board at the end of each academic year.

Assistant barber instructor registration shall be renewed on each even numbered year and shall be valid for **three** years from the date of registration if the registrant pursues, without interruption, the educational requirements.

Any registrant that fails to maintain the educational program shall have his or her registration revoked. A revoked registration shall be reinstated if all fees are paid and all other registration requirements of this subsection are met.
